Following a brief pause Captain Hampson will pronounce the Exhortation.

"Last Post" and "Reveille" will then be sounded by buglers of the Royal Navy (by kind permission of the Commodore, R.N. Barracks, Chatham).



THE CASE FOR INCREASED RATES OF WAR DISABILITY PENSIONS.

DESCIOUS TO ALL MIL A THESTER THE RI-FRIVATE RECEIVES HALF AS MUCH AS THE

BLESMA is a voluntary membership association of men who have lost one or more limbs as a result of their war service, officially recognised as the body representing the 36,000 British limbless war pensioners. There are 106 branches in all parts of the United Kingdom.

Our Association is campaigning for fair compensation for all ex-Servicemen Who suffer loss of sight, limbs or effects of other severe war wounds, the men who were torpedoed, who crashed in burnt out planes and gliders, were blown up by mines on land and sea, or were otherwise Wounded in all parts of the world in close contact with armed enemies. soat of increasing the look rate

These men have no access to legal or arbitration courts or any independent body. They are entirely dependent on the goodwill of the Government of the day in regard to their rates of compensation.

The maximum 100% rate of war disability pension for totally disabled ex-Privates was fixed at 40/- a week at the end of 1919, and this amount was at that time related to the minimum Wage for a labourer.

This rate of 40/- a week has been increased only once, in 1946, to 45/a week, which is now only worth 21/8d. by comparison with 1938 purchasing values.

The pension of 27/- a week for an ex-Private's arm or leg is only 3/- more than it was in 1919, and has a purchasing value of only 13/- by 1938 standards.

War disability pensions have now lost all relation to present day higher values, wages, prices and benefits.

Past Governments have stated that they could not afford general increases for all war pensioners and they have introduced a form of needs test, with supplementary allowances for the extremely disabled and the unemployables.

> only 6% of all the 724,000 war disabled pensioners, and less than 10% of the 36,000 limbless pensioners, receive any of the supplementary allowances.

Our members strongly object to official statements that nearly all the war Risabled are working, and that their pensions are handsome tax free additions to Wages .

> War disability pensions are, by the terms of the Royal. Warrants, compensation for physical damage without regard to earnings or lack of earnings. They are also compensation for loss of amenities and pleasures of life, for pain and mental and physical stress and strain, and the burden of wearing artificial limbs for a lifetime.

BLESMA members have grown impatient with the apparent futility of their persistent representations and deputations to the Ministry of Pensions, who are powerless to meet our requests until more money is made available.

/In their

In their branches and in National Conference our limbless men have resolved not to tolerate the present position quietly any longer, and to engage in a vigorous campaign to secure just compensation.

Their demands are fair and reasonable.

THEY ASK THAT ALL RANKS BELOW THAT OF LIEUTENANT SHALL RECEIVE THE SAME PENSION FOR THE SAME DISABLEMENT ON THE GROUNDS THAT SIGHT AND LIMBS ARE EQUALLY PRECIOUS TO ALL MEN. AT PRESENT THE EX-PRIVATE RECEIVES HALF AS MUCH AS THE LIEUTENANT AND CONSIDERABLY LESS THAN A WARRANT OFFICER.

THEY ASK THAT THE 100% BATE FOR ALL TOTALLY DISABLED OTHER RANKS BE INCREASED TO MORE NEARLY CONFORM TO PRESENT DAY VALUES AND TO THE RATES PAID BY OUR DOMINIONS, AMERICA, FRANCE AND BELGIUM, WHICH ARE APPROXIMATELY DOUBLE THE BRITISH RATES, ALTHOUGH WOUNDS WERE RECEIVED ON THE SAME BATTLEFIELDS AND IN THE SAME CAUSE.

The cost of increasing the loof rate of 45/- a week for totally disabled ex-Privates up to the 61/8d. now paid to W.O.ls. would be approximately flo million.

The cost of increasing the loof rate for all totally disabled Other Ranks up to #4 a week would be approximately £22 million.

THESE SUBSTANTIAL INCREASES AND COSTS ARE JUSTIFIED BECAUSE THE CAP BETWEEN WAR PENSIONS AND HIGHER PRICES, WAGES AND BENEFITS HAS BEEN ALLOWED TO GET WIDER YEAR BY YEAR. THE GAP SHOULD BE BRIDGED NOW, BEFORE ANY FURTHER CHANGES IN VALUES TAKE PLACE.

Past Governments have said that they could not afford to increase the compensation for the men disabled in the service of the State. The government have no more right to say they cannot afford to pay than have the Insurance Companies who now have to pay the much higher damages awarded by the Courts for personal injuries in the workshops and on the roads, etc.

We now have a new Government, coming into power within a few days of Remembrance Day. One of their first tasks should be to give special consideration to the needs of Britain's 700,000 men who were disabled in war and, with their 900,000 comrades who gave their lives, helped to win the victories which preserved our democratic way of life, with free elections and a free Perliament.
