#### HEMEL HEMPSTEAD

Her Majesty will first visit Hemel Hempstead to lay the foundation stone of St. Barnabas Church, Adeyfield.

Adeyfield is the first neighbourhood to be developed in the New Town by the Hemel Hempstead Development Corporation (See Appendix 2 and last page of the Service Paper).

St. Barnabas Church is the first of the Seven New Churches which come within the Seven Churches Campaign of the Diocese (See Appendix 1).

## The Processional Route

Begins at Two Waters where the Queen is expected at 2.55.p.m. (Mr. P.Schwabe, C.O.I. Eastern Region, will arrange for press cars to follow the procession from this point, if this is desired.

The route to Adeyfield Square is by Marlows, Alexandra Road, Midland Road, Broadfield Road and Longlands.

The Hemel Hempstead Borough Council in conjunction with voluntary organisations in the Borough have arranged for the decoration of these streets. Flowers and greenery from gardens all over the town are being used in addition to flags and bunting. Marlowes Arch and the entrance to Gadebridge Park are focal points. # Visit to the Abbey

#### Evensong

The cloth of gold covering the desk before the Queen's seat was used at the Coronation of Queen Victoria in Westminster Abbey on June 28. 1838. It afterwards became the property of the Reverend Lord John Thynne. sub-dean of Westminster then acting for the Dean and, by him presented to the Church of St.Mary at Haynes (in the Diocese of St.Albans) to be used as an Altar Cloth. 170 1. 7.6

The prayer book which the Queen will use, and which is a gift to her by the Abbey, contains the names of the new reign in the prayers for the Royal Family. It is an Oxford University

Press bound in blue levant leather with the arms of the Abbey stamped on the cover in gold. The Queen will be invited to sign a duplicate copy given by Canon Webb-Bowen for the Dean's Stall.

All arrangements for the visit of Her Majesty to both Hemel Hempstead and St.Albans have been co-ordinated by the Diocesan Secretary, working in close co-operation with the authorities concerned.

# THE TASK AHEAD.

The C<sub>h</sub>urch of S<sub>a</sub>int Barnabas at Adeyfield is the first of seven new church buildings for which the Diocese of S<sub>a</sub>int Albans is endeavouring to make provision in celebration of the 75th A<sub>n</sub>niversary of its formation. To this end it is seeking to raise £75,000 by the S<sub>e</sub>ven C<sub>h</sub>urches Campaign.

The total amount received (representing cash in hand and the amount which it is estimated will result as covenanted subscriptions mature) is £51,254. Contributions from the parishes, from personal subscribers and industrial firms are coming in day by day.

Newcomers to the Diocese

These seven new churches are planned as a thank-offering for the past and a pledge for the future; they are but a first instalment of the programme for finding clergy to minister to, and churches to build up the faith of, the people who are crowding into the two counties of Hertfordshire and Bedfordshire.

Already 4,000 newcomers are housed in the Adeyfield and Bennetts End neighbourhoods of Hemel Hempstead; over 40,000 are expected as the Development Corporation's plans mature in 1958. The "new towns" of Stevenage and Hatfield will provide homes for another 53,000 people. Vast housing estates are being built by the London County Council at Boreham Wood, and also at Oxhey Place where over 15,000 people are already housed.

The Church in this country faces everywhere new claims in days of rising costs. The problem of due provision for the Ministry and of the supply of candidates for Holy Orders calls everywhere for new imagination and generosity - and this must be the first charge on all church people. The maintenance, re pair and reconstruction of ancient parish churches and church schools strain the resources of the Church throughout the country. But the Diocese of St. Albans, more perhaps than any other, faces a task which will need all the initiative and enthusiasm which can be given to work for the Kingdom of God. All those who are seeking to fulfil it are greatly encouraged by the desire of Her Majesty the Queen to visit the Diocese and to lay the foundation stone of the new church at Adeyfield.

# The Plan of the Church

St.Barnabas Church has been designed by Mr.Felix J. Lander, F.R.I.B.A. The complete scheme comprises a church to seat just over 300, church hall and parsonage house. The house will be built some time in the future but the hall only if it is found there is a need for it. The church is planned planned so as to provide as far as possible an unobstructed view of the alter and, although the width is approximately the same as the length of the nave, the effect of length is obtained by having the roof of the aisles at alower level, so that the nave and sanctuary together form a long rectangle.

It is intended that the choir and organ (when the latter can be afforded) should be accommodated in a gallery at the west end. Underneath the front of the gallery there will be a sliding folding partition; this portion of the Church can thus be cut off and used for services when there is likely to be a small congregation and an altar is provided in a recess on the south side. This will save heating the whole of the Church on week-days.

The buildings will be of yellowish bricks to conform with those used nearby. The first portion of the Church to be built will be the nave and sanctuary, including the gallery at the west end, and one largish room to be used as a vestry. There will be a temporary porch and temporary walls filling the openings left for the future aisles. It will seat 150 to 160 people.

# THE NEIGHBOURHOOD OF ADEYFIELD

Adeyfield is the first of the new town neighbourhoods to be built, and will eventually have a population of about 9,500. There are now about 3,500 new residents, most of them from north-west London - and about 1,500 who were in the area before the New Town was designated in March, 1947.

The movement of large numbers of people to a new district, and in a short space of time, raises many problems, principally of a social nature. Ample proof of the desire to establish a thriving community is the fact that there are now nearly 25 social organisations, all of which are active even if in some cases membership is small. To co-ordinate the activities of these societies and to help to solve some of the social problems in the area, the Adeyfield Neighbourhood Council was established early this year.

#### THE PHYSICAL BACKGROUND

Adeyfield Square, where the Church of St.Barnabas is being built, will eventually comprise 25 shops (among them a Branch Post Office, Grocer, greengrocer, newsagent, ironmonger, shoe repairer, confectioner, hairdresser, restaurant and dairy, and cooperative stores) a public house, and an assembly hall to seat 300. To the south of the Square will stretch many acres of playing fields, including tennis courts, gardens and a children's playground.

Adjoining these playing fields will be the new Secondary Modern School, for 480 children, which will be open in about three months. Primary education is provided in the established Maylands School, where about 600 children can be accommodated.

#### INDUSTRIAL ACHIEVEMENT

The seven factories, built or building, will provide sufficient comployment for nearly 5,000 workers, and when fully developed approximately half of the new industrial development of Hemel Hempstead will be complete. With the factory just round the corner, none of the new workers has more than a short cycle ride or a few minutes walk to reach their factories, and in this way, an appreciable saving is made in family budgets;
