- <u>CAR-PARKING:</u> Arrangements have been made for the cars of the above units to be parked on the Promenade Bandstand Extension, opposite the White Rock Pavilion (behind the Red Cross vehicle).

 Please make sure that your representatives bring these. The passes should be individually retained throughout the day. The Police and all staffs concerned will recognise them and pass their bearers.
- CHURCH SERVICE: Seats have been reserved at Holy Trinity Church for any commentators who may desire to attend. The sermon will be preached by the Mayor's Chaplain (the Rev.J.L. Napier).
- PROCESSIONS to The route is only a short one and an advance recce is desirable and from Church: to pick out vantage points. W.H.Dyer will be available to assist in this connection. The processions will be "in state" all Mayors, Barons of the Cinque Ports and Officers wearing their full robes. Sir Winston will not attend the service.

 ARRIVAL:

 He will get out of his car at the main entrance to the White Rock
 Pavilion. The steps will be lined by the Guard of Honour (the
 South African War Veterans). He will be received in the Foyer by
 the Speaker of the Courts (the Right Worshipful the Mayor of Hastings,
 Alderman F.T.Hussey, J.P.). Photographers who desire to shoot his
 arrival can do so from the top of the steps provided they make a
 quick getaway before he arrives at the actual entrance. This
 reception by the Speaker can be shot from the balconies overlooking
 the foyer.
- FIELD-MARSHAL Lord Montgomery will be met at the Borough Boundary at 11.45.a.m. and escorted direct to the White Rock Pavilion.
- DURING THE and there will be smple room for all and equal opportunity from any position in this reserved space. Distance from stage where presentation will take place, about 50 feet. Adequate lighting has been arranged.
- THE PRESENTATION: At the appropriate moment, the portrait, which will be positioned above and behind Sir Winston and the Speaker, will be unveiled and spot lighted.
- LUNCH:

 Owing to spatial considerations, only commentators and reporting press will be accommodated at the official lunch. In compliance with Sir Winston's wishes, it is requested that there should be no photography at the lunch (other than a general view should one be wanted).

This is a momentous occasion, of which this

Confederation has cherished hopes for a long time
the occasion for the Cinque Ports to honour their

distinguished Lord Warden.

You, my Lord Warden, will no doubt recollect that at the commencement of our Court, I asked for permission for your attendance, which was unanimously and spontaneously given.

This, as you may also know, is necessary by ancient custom, because in olden days the relationship between the Lord Warden and the Cinque Ports was not on the same happy basis as to-day. Whereas then it was not always easy to agree that the Lord-Warden should be present at a meeting of the Courts of Brotherhood and Guestling, to-day we count it a great privilege that you should be with us.

The Lord Wardenship of the Cinque Ports is now regarded as an honour to be conferred on one who has rendered signal service to the State. If such is the case, never could the honour have been more richly deserved. It was therefore an historic and great day for the Cinque Ports Confederation when His late Majesty King George VI appointed you, Sir, as Lord Warden on the 15th October, 1941.

It was at this time, when you had been in command of the ship of state for about 18 months, that the whole of our peoples - and also peoples in many other countries had been encouraged, stimulated and inspired, during a very difficult period, by your leadership, and particularly may I say, by many of your phrases that in themselves made history, as well as ensuring the greatest all-out effort made by every section of our people.

When this country stood alone, you proclaimed it
"Our finest hour." We remember your declaration that
"Never was so much owed by so many to so few"; - your
tribute to the gallant band of Airmen - "We will fight
them on the beaches" - you hurled at the foe across the
Channel. These words of yours are a few that readily come
to mind The last is of particular significance, and stood
out to all of us in our home towns of the Cinque Ports.
We all knew how near at one time that was to reality,
and no matter how distressing may have been the outlook,
we were spurred on in whatever job we were doing, by your
indomitable courage, leadership and the truly magnificent
broadcasts that meant so much to everyone of us.

Throughout our proud and ancient history, the hour has fortunately for Britain, invariably produced the man. How right this proved to be from 1940 onwards; how right for the future of our own country; how right for the future of the civilised world - and we are all here to-day to pay our sincere tribute to the man who, in the darkest days of our history, was able to weld our whole peoples into such a magnificent team.

The portrait, my Lord Warden, painted by Mr. Bernard Hailstone, depicts, we believe, in the setting of yourself against the cliffs of Dover, the grimmess of the struggle of those days. It is my privilege and pleasure, Sir, to ask you to accept this portrait as the tribute of your own Cinque Ports to their greatest Lord Warden.
