## GERMAN NEWSFILM PRODUCTION

### Protest against Anti-Semitism

In a statement before the Berlin Legislative Chamber Willy Brandt, Lord Mayor of Berlin, declared:

"We in Berlin shall not allow any neo-nazistic groups to expand. Wherever we should discover them - they will be extinguished, because that is our moral and national duty."

The Berlin authorities were very soon able to become active. On Wednesday night the 49 year old municipal-inspector Alfred Staats and two other persons (the 17-year-old Anel Wäse and an 18-year-old baker-apprentice) entered a restaurant in Berlin-Schöneberg with "Heil Hitler". They were immediately arrested.

48 hours later - on Friday - Staats already appeared before a Berlin Court. He was sentenced to 17 months prison.

On Friday night more than 50.000 Berliners marched to the memorial for the victims of Fascism at the Steinplatz (Zoo) In his speech Senator Lipschütz reiterated the determination of the Berlin authorities to quench any trends towards a renewal of nazism.

INTERVIEW WITH DOCTOR ROPER

S.V. DOCTOR ROPER SPEAKING

Even if these exhibitions of Nazism, of Anti Semitism are insignificant in the sense that they're only <sup>FEW</sup> ~~some~~ of them comparatively speaking, even if they are the results of Juvenile Delinquency rather than the organized renaissance of the evil thing. I find them most disturbing and I'm anxious that they should be opposed, that we should denounce them at once. Because remember what happened 25 years ago. This is an evil thing, it's politically wretched, it's ideologically absurd, but basically it's something that's morally rotten and it's for that reason, above all reasons that you and I ought to seek to exterminate it, exterminate it from our own thinking, exterminate in any way in which we have the power to try to eradicate it. Therefore I hope that every person whatever his political or religious views he will regard this as a degradation of human life and will seek in every way possible to get rid of it before it takes hold, and we repeat in our generation the horrors that once we knew.

I don't know how wide-spread or how highly organized these expressions of Nazism and Anti-Semitism are, but I regard with horror. I think they're most sinister and I'm anxious to oppose them with every sort of condemnation of which I am capable. Because this represents an evil thing, it's politically absurd, it's ideologically rotten, it's practically dangerous, but above all it's a degradation of human life.
